#### CIAG MEMBERS DONATE TO CLSUAAI HOSTEL PROJECT

CIAG members, friends and supporters responded to the solicitations made by the Central Luzon State University Alumni Association, Inc. (CLSUAAI) and the CLSU Alumni Foundation, Inc. (CLSUAFI). During the CIAG September 2010 Reunion in Las Vegas, Dr. Eliseo Ruiz, President of CLSUAFI briefed CIAG members and supporters, and gave an inspiring summary of the developments of the CLSUAFI Hostel Project. He also encouraged CLSU alumni all over the world to provide generous financial support for the completion of the Hostel Project.

During his briefings, Dr. Ruiz indicated that so far P12 million pesos have been spent on the project and approximately an amount of P5 to P6 million pesos more is needed to complete everything. He indicated that when the building is eventually finished, it would be the biggest, the tallest and the most beautiful building on campus.

Dr. Ruiz also explained during the Las Vegas Reunion that if any CIAG members/supporters would be able to contribute an amount enough to build and furnish a room, said room will be named after the donor and he/she including immediate members of his/her family will have free use of the room except telephone bills, laundry and internet connections charges for lifetime. However, each stay shall be for maximum of ten (10) days in any month of the year.

### EDITORIAL

#### **ON CIAG MEMBERSHIP**

t is gratifying to note from the Treasurer's column last issue that CIAG has 76 members who are current in their \$10 annual membership dues including nine life members (those who paid \$100). Our current roster of membership

lists more than 180 members and most of these are couples. Counted separately, we can safely assume that we have more than 300 alumni, former faculty/staff and CLSU friends For an organization which is only a few years old, having 25.3% of its base fairly active is a decent figure. Undoubtedly the Las Vegas grand reunion last September was a big factor for this positive outlook. Can this level be sustained, or even be improved? That remains to be seen.

A couple of years ago our web master, Rob Bugawan started maintaining the membership roster along with the Secretary and the Treasurer with further good suggestions from one of the newly elected regional vice presidents, Rene Cuizon. It is also common knowledge that during national events like our recent Las Vegas grand alumni reunion, we were able to gather more information. Word of mouth from fellow alumni and friends also has proven to be effective.

Other ideas can be explored. To help maintain and expand our roster of members, how about the Membership Committee delineating the boundaries of the regions and listing the current members. Perhaps once that is done, CIAG can put up annual contest and award a prize to the region with the highest percentage of new members recruited.

Some alumni organizations that experienced a high success in maintaining their membership have utilized strategies that 1) kept the members sufficiently interested and involved, aside from paying their annual membership dues, and 2) continued consistently to maintain and expand the membership roster. One example that I have observed was from my sister's nursing college alumni association. In addition to their international alumni group, they organized sub-chapters in the major U.S. cities with complete set of officers in those local sub-chapters. They hold leaders annual meeting for their local presidents and vice presidents aside from their biennial general membership meetings.

Finally, there is truth that there is superiority in number and in quality for even if we have a membership of 1,000 but only 5 or 10 are very active and the rest are spectators, or if we have a very active group of alumni but there are only 30 or 35 members, projects like our Endowment Fund will not fly. We do need both, a robust amount of quality and quantity, -frg.

#### FROM THE TREASURER'S DESK



As of March 10, 2011, CIAG's bank account balances at Wells Fargo Bank totaled to \$13,717 and broken down into:

Endowment Fund (EF) \$10,175 Interest earned (EF) \$ 78 Scholarship Fund \$ 2,000 General Fund \$ 1,464

The fundraising activities during the CIAG Second Grand Reunion held in Las Vegas, Nevada last September 2010 generated close to \$4,000 in net proceeds. Once again, our sincere thanks and appreciation to over 150 alumni/friends from USA and Canada for their overwhelming support, without whom, the reunion would not have been a great success. And more importantly, the presence of dignitaries from the Philippines (Dr. & Mrs. Ruben Sevilleja, Dr. Zenaida Serna, Dr. Ely Ruiz, Dr. Romeo Padilla and Dr. Nestor Alvarez) made the occasion extra special and memorable. Thank you!

The officers and members present during the December 2010 CIAG Meeting in Santa Clara, CA unanimously voted to donate \$2,000 (PhP 86,384) to the CLSUAAI Hostel Project. The resulting account balance of CIAG after the \$2,000 donation to CLSUAAI is \$13,717, which amount decreased from \$15,024 in January 2011. The remaining fundraising proceeds (\$2,000) have been set aside to fund CIAG's Scholarship Program commencing

this year with scholarship awards to two students at \$300 per student per year.

With respect to the CIAG Endowment Fund, I am pleased to report that this Endowment Fund has increased by \$2,150 since the beginning of Year 2011, from \$8,025 to \$10,175 as well as the number of donors, which increased from 26 to 30.

Notably, Dr. Ed Cabacungan (Endowment Fund Committee Chair) and his lovely wife, Nenita recently completed their pledge of \$1,050 (in memory of beloved son, Allen Caan Cabacungan) and have pledged another \$1,000 payable in the next five years. New donors like Wayne and Maxima Simon-Puzon (in memory of their son, Peter Simon Puzon) have donated a total of \$300 to CIAG EF. Also, from non-alumni like Jeff and Edita Cabacungan-Donnelly, donations totaling \$1,800 have been received; and Tony & Ging Viray-Flora (in memory of beloved father, Prof. Juan P. Viray), a total of \$500. Alumni from Canada (Marietta Abenes-Solano, Lulu Abenes-Rodriguez and Florentina Alcos) have continuously sent their donations to CIAG. #### CIAG Members Donate to CLSUAAI HOSTEL PROJECT

In recognition of the donor's contribution, a plaque bearing his/her name or the association/ organization with brief citation will be hung or secured at the backside of the main door.

To date, CIAG individual members and supporters, and CIAG Groups have contributed a total of PHP868,794 pesos or approximately \$19,972 (assumed average rate of PHP43.50 per US dollar. The Galinato Brothers namely: Engr. Gerry Galinato (Idaho), Engr. Damian Galinato (Texas), Noli Galinato (South Carolina) and Tino Galinato (Texas), individually and collectively opted to donate an amount of PHP515,800 pesos (\$12,000) to fully complete 3 rooms on the second floor. Architect Manny Ruiz of Las Vegas also pledged to fund one room in the second floor. A CIAG US-Canada Group also elected to support the completion of one room and has contributed an amount of PHP65,038 pesos.

Other members responded by donating various amounts in cash and in checks ranging from \$100 to \$300 and given to Dr. Serna before leaving Las Vegas. Such donations will be used to support various hostel project components such as fences, and general construction items. CIAG members and supporters continue to give donations direct to CLSUAAI.

The list of CIAG-member donors are listed in the following table. Please note that utmost care and accuracy were observed in listing the names of donors. However, if you find discrepancies in the list, please let the editorial staff know so appropriate corrections are made.

Dr. Ruiz also mentioned during his briefing that CIAG previously requested former CLSU President and CLSU Centennial Foundation, Inc. President Dr. Rudy Undan to turn over the remaining amount of the Centennial Funds to the CLSUAAI for the Hostel Project. A total amount of P428,040 pesos was officially transferred to CLSUAAI Hostel Project to support the completion of the project.

The CLSUAAI is still continuing to solicit donations from CLSU alumni, supporters and friends to support the completion of all the rooms of the Hostel Project. If you have not done so yet and are interested to support the cause, please make the necessary donations to CLSUAAI.

ur new 1<sup>st</sup> Vice President, **Juanito**E. Campos was born in Ariston,
Asingan, Pangasinan. He recalls
that being born from a very poor share
cropper family, he was able to go to
high school in CLAS with the help of
his late older brother who worked at
the pineapple plantations in Hawaii.
After high school, he joined the

Philippine Navy and through a competitive examination conducted by the US Navy, was sent to the Naval School Supply Command for a six-month study in storekeeping. He finished the course on top of his class of 30 students.

Manong Johnny, as he is fondly called by many of his friends, met his beautiful wife, Julia Magno, while in the States. He was at the Naval School Supply Command while Julia, who by the way, became the first Dean of CLSU College of Home Economics, was on a scholarship pursuing a master's degree in Oklahoma State University. After a whirlwind courtship, they got married in Oklahoma City in 1955. They were blessed with three children, Judy, Jun and Julius, now all grown up with their own families.

Manong Johnny earned a BSE degree from Cosmopolitan Colleges in Manila in 1950, a BSA in CLSU in 1965 and a Master of Arts degree in 1954 from Far Eastern University. He immigrated to the United States in 1971 after teaching in CLSU for two decades. While in the States, he took an examination for Deputy Clerk in the San Francisco Municipal Court and placed among the top ten who passed. He became the only courtroom clerk who is not a lawyer. He is also very active in community service. Right now, he is serving his eighth year as President of the Filipino -American Senior Citizens of Solano County, Inc. He also served as Worshipful Master of Columbia Brotherhood Lodge No. 370 in 1981.

Ohma retired as Vice President from the Commercial Real Estate Department of Bank of America in Sacramento while Lito retired as a Senior Bridge Engineer from the State of California Department of Transportation.

They are currently residing in Elk Grove, California and having the most wonderful time together. Since retirement, they have been very active in Masonic and community affairs. She and Lito are the Junior Past Royal Matron and Royal Patron of Beehive-Sacramento Court, Order of the Amaranth. They are also active members of the Order of the Eastern Star, Temple Chapter in Sacramento. Ohma currently serves as the Editor of The GDML Journal published monthly by General Douglas MacArthur Lodge #853 (GDML), Sacramento, California. Lito was the Charter Master and currently serves as the Worshipful Master of GDML.
